Dear CTV, Global News, the CBC, and Elected Officials,

Without Prejudice

As per the Broadcasting Act the media are to report on matters of public concern without bias.

(i) the programming provided by the Canadian broadcasting system should  
(iv) provide a reasonable opportunity for the public to be exposed to the expression of differing views on **matters of public concern**.

The media continues to fail in its duty to do so. It would be interesting to know if a class action lawsuit against one individual news source would help motivate a return to honest reporting.

The recent reports demonizing MP Michael Cooper for taking a stand at a Parliamentary hearing against defamatory comments made by Faisal Khan Suri, the President of the Alberta Muslim Public Affairs Council, appears to be in violation of Motion M-103 as the media, and Mr. Suri, facilitate hate and intolerance toward 'white' Canadians.

Did any reporter actually take the time to read the minutes of the Justice Committee proceedings in an effort to understand the context of what is being discussed before providing the news?

Rather than legitimize Canadian's concerns over the rising threat of Islamic criticism toward westerners, the media is reinforcing the rhetoric and facilitating the elimination of much needed debate.

Mr.Suri indeed linked the shooters of the Quebec Mosque and that of New Zealand to "alt-right and **conservative** commentators". There is no mistake or misunderstanding in what was said.

MP Cooper responded by saying, "I take great umbrage with your defamatory comments to try to link conservatism with violence and extremist attacks," he said at the time. "They have no foundation. They are defamatory. And they diminish your credibility as a witness."

Mr. Cooper also referred to the manifesto outlining details of the New Zealand shooter who was a self proclaimed **communist**.

Mr.Suri quickly took advantage to self-victimize and turn Mr. Cooper's comment into a personal attack and also made a false statement claiming the manifesto was a 'banned document'. The document is not banned in Canada and thankfully Mr. Cooper had taken the time to read it and ensure the facts were available to those who were attending the meeting.

Mr. Suri said in an interview on Sunday, "What is deeply concerning is the fact that Mr. Cooper had the manifesto in his possession and read it in a parliamentary committee as a federal MP," "This is a document from a white extremist who murdered 51 innocent people. That is concerning."

"White" extremist?? Mr. Suri is permitted to racially profile an individual but Canadians are forbidden to point out the horrendous crimes against humanity being witnessed across the country and all over the world at the hands of Muslims. Where is Mr. Suri's outrage in defending fellow Canadians regardless of race or religion? Where is Mr. Suri in speaking out against the horrendous attack in Danforth or the hate filled speeches at the 'public' Palestinian Al Quds Day events wherein children are being indoctrinated into hate and violence against their neighbour and fellow countryman? (attached image, 2019, is evidence of the vile hate perpetrated by Islamists calling for the massacre of Jews). Where is Mr. Suri in condemning the vile hate being preached in mosques across this country? Where is Mr. Suri in

addressing the radicalization of youth through Canadian mosques and on the internet?

A further question is why it is acceptable for Mr. Suri to use the name of Alexandre Bissonette but does not mention the Danforth shooter, Faisal Hussain? Why is it that other Muslim Witnesses, who attended the parliamentary meeting to discuss on-line hate, used the Quebec Mosque shooting as their only 'Canadian' source as evidence to support the agenda to concoct an image of hate directed solely at Muslims. Could it be that Canada is not actually struggling with systemic racism or Islamophobia?

Where are the elected officials or the media or any of the Islamic Witnesses in condemning the hate perpetrated by Islamists?

During the Parliamentary meeting Dr, Jasmine Zine gave a shocking account of information that is inflammatory and provided by groups associated directly with extremism in an effort to undermine the valid concerns of Canadians in the face of Islamic take over of Western Nations. The UK and Europe are evidence that the concerns are legitimate and Dr. Zine's comments appear to reflect the position of someone who is operating solely to facilitate the false narrative of "Islamophobia" and intolerance toward Muslims. This eerily aligns with the Muslim Brotherhoods directive in the [Explanatory Memorandum](#), and other MB scripts, to shut down opposition through self-victimization, silencing opposition through Islamophobia motions, attacking freedom of speech and ultimately and effectively "destroying their miserable house from within"

*"Currently, I'm conducting a study funded by the Social Sciences and Humanities Research Council on mapping the **Canadian Islamophobia industry**, along with the **National Council of Canadian Muslims**. By the term "Islamophobia industry", I am referring to a constellation of individuals, groups, think tanks, politicians, academics, institutions, grassroots organizations, media outlets and donors who manufacture, produce, distribute and attempt to normalize fear, bigotry and hatred toward Islam and Muslims.*

*The research I am doing examines and maps the political, ideological, institutional and economic networks that foment Islamophobic fear and*

*moral panic in Canada. This is essentially an industry of hate, which operates through a variety of tacit and overt means and intersects within a broad, interconnected transnational network. The web of associations in this network connects Canadian white supremacist and white nationalist groups—who, according to Barbara Perry's research, have grown in number from upward of 100 in 2015 to almost 300 in 2018—with a variety of other groups, organizations and individuals that form the soft power behind this industry and the dog-whistle extremist rhetoric often guised in liberal discourses about **upholding free speech, preserving Judeo-Christian democracy and safeguarding Canadian values** from the threat of Muslim infiltration. They use online platforms to purvey their ideologies of **hate, racism and xenophobia**, and connect with other alt-right groups that are rooted in **neo-fascism, misogyny, homophobia, transphobia and other forms of bigotry**".*

Wow, this is definitely an impressive use of terms Canadians would not have even considered as part of our daily vocabulary just a matter of years ago. And they are highly effective in undermining and replacing the legitimate concerns of Canadians when considering the impact Islamic infiltration is having around the world.

Muslim MP Iqra Khalid, along with the Islamic leaders who strategically coordinated the Islamophobia attack against Canadians, tabled Motion M-103 on Dec. 5, 2016. It was the most "deeply divisive" document presented to parliament and it is the foundation to the ongoing controversy we continue to face today. Tearing at the fibre of this great nation Islamic leaders press on to aggravate Canadian values and principles by making objectionable demands. Islamophobia motions are occurring in all Commonwealth nations and are the birthing point of Islamic take over.

Motion M-103 marks the day Islamists ignited an aggressive war against Canadians.

According to the final report by the Standing Committee on Canadian Heritage Motion M-103, the Islamophobia notion, was proven to be a farce. Despite this it would appear the Islamic community are working overtime and in sync to victimize the Muslim community and set themselves above and apart from the rest of Canadians. In turn, and as a matter of strategy, they then claim discrimination when expected opposition is applied. Bill 83 in Ontario is a perfect example of Islamists

making a demand for special treatment which is contrary to the will of fellow Canadians. The Islamic community are relentlessly pushing for a Nat'l Day of Remembrance in spite of the fact that Canadians have repeatedly objected to this. They are intentionally ostracizing themselves and then chastizing Canadians.

Mass rapes, no go zones, stabbings and crimes against the people are unreported due to the same restrictions trying to be imposed on Canadians. The censoring has prevented the world from knowing that cities and towns throughout Europe and the UK are being destroyed from within.

Asylum minister Mark Harbers from the Netherlands resigned recently after it was discovered figures about the number of refugees suspected of violent crimes were 'hidden'. Mass rape and murder throughout Europe and the UK are rampant as are no go zones. In Canada a Syrian refugee was recently arrested for raping an 81 year old woman in Edmonton. Another refugee raped a 47 year old woman in Ontario. There are no go zones growing across Canada and our law enforcement and media are already being prohibited from providing crime stats directly associated to the Islamic community as it would conflict with Justin Trudeau's sunny ways arrangement with the UN to bring in as many refugees as possible from foreign countries who do not share our values.

The details surrounding both the shootings at the Quebec Mosque and the one in New Zealand are suspicious and the public have reason to question what the government and the media have reported. Why is there a double standard in protecting Islamists when it is well documented they are on record committing the greatest number of acts of violence and hate speech? None of which is addressed in these meetings.
